C O N S T I T U T I O N

KURIGRAM SAMARAN PATHAGAR, P.O. KURIGRAM, DIST. KURIGRAM

WHEREAS, the SAMARAN PATHAGAR, KURIGRAM is going without a Constitution since its establishment and whereas its members now desire to adopt a new Constitution it is, therefore, resolved that the following Constitution be adopted for the purpose :-

1. The Institution shall be known as KURIGRAM SAMARAN PATHAGAR.
2. The library shall be administered by an Executive Committee to be elected every three years in a general meeting of the members to be held in the month of January. The Executive Committee shall be constituted with one President, two vice - Presidents, one Secretary, one Assistant Secretary and six other members.
3. The Deputy Commissioner, Kurigram shall be the ex-officio President. The Librarian shall be the ex-officio Assistant Secretary and all other members of the Committee shall be elected every three years term.
4. 6(six) members shall form the quorum of the meeting. .
5. The Executive Committee is empowered to appoint a part-time Librarian and a bearer.; subscribe Magazines and periodicals and News Papers and to purchase books and to raise fund for the Library.
6. An elected office - bearer or member of the Executive Committee may be removed by the General Meeting or an extra Ordinary general meeting with a two -third majority of members present in case he is found negligent in discharging his duties and responsibilities or otherwise undesirable.
7. The Executive Committee shall ordinarily meet two a month but there shall be at least one meeting in four months.
8. A casual vacancy among the office - bearers shall be filled by election in an extra - ordinary general meeting and that among other members of the Executive Committee by co-optation.
9. An extra-ordinary general meeting may requisitioned by one third members of the library and emergency meeting of the Executive Committee may be similarly requisitioned by six or more members of that Committee.
10. An ordinary meeting shall shall be convened by the Secretary and extra-ordinary or emergency meeting by the President, Seven Days notice shall be required for an ordinary meeting.

The Secretary and the Assistant Secretary shall keep all Accounts of properties of the Library and shall jointly and severally hold responsible for them.

12. In the absence of the Secretary, the Assistant Secretary shall have the power of the Secretary temporarily. The Assistant Secretary will assist the Secretary in all matters.
13. An Auditor should be appointed by the Executive Committee to audit the accounts of the Library.
14. In the General Meeting the Secretary shall place the following matters for approval :-
- (a) Audited accounts and financial condition.
 - (b) General Condition of the Library including review of Book - stock.
 - (c) Miscellaneous.
- 15.(a) Any resident of Kuching Town may be a member of the Library.
- (b) Any person living outside the limits of Kuching Town may be a member of the Library provided his application is considered and accepted by the Executive Committee.
- (c) Any person willing to be a member of the Library shall have to apply in prescribed form coupled with a deposit of Tk. 200/- (Two Hundred) only.
16. Membership shall automatically cease after a consecutive default of three months in payment of subscription.
17. All the existing members of the Library will automatically become members under the New - Constitution and the provisions of the clause 16 will be operative on them after two complete months from the date of adoption of the Constitution.
18. The Executive Committee shall have the power to frame temporary new Rules for the effective and smooth running of the Library. The Rules thus framed should be placed in the next general meeting for approval.
